

# **DRAFT 90<sup>th</sup> Administration University-Wide Senate Meeting Minutes**

September 19, 2019

- I. **Call to Order: SGA President Jazmin Mejia at 7:41 pm**
- II. **Opening Call of The Role & Determination of Quorum: Senate Clerk - Brittany Dankwa**  
(Absent: Senators Baig, Tinsley, Manning, Beal, Staine, V. Jones, Moyer, Gongora, Zolnik and EVP Turner)
  - It should be noted that SJB Justice Murray was in attendance.
  - Quorum is achieved with 28 present senators out of 37.
- III. **Reading & Approval of the minutes:**
  - A. **From the previous meeting on August 10, 2019.**
    - i. **Senator Saed, Ebiringa, and Walker make amendments** to misspelling of names. **Senator Abraham** approves the minutes. **Senator Walton** seconds the motion.
    - ii. Vote to Approve: 28 votes for.
- IV. **Special Reports: n/a**
- V. **Special Orders:**
  - A. Senator J. Jones presents a University-Wide special order to seat a chairperson for the Bylaws Committee, due to the resignation of Senator Danny Mai for personal reasons. This legislation would seat Senator Andre Walker as the Chair of the Bylaws Committee.
    - i. Senator Abraham calls to question, seconded Senator Le.
    - ii. 24 Votes For. 0 Against. 0 Abstentions
- VI. **Executive Cabinet Reports**
  - A. **Atlanta Campus**
    - i. **EVP Rahman** – Discusses establishing the ad Hoc Government Affairs Committee on the Atlanta Campus. Members will be chosen and appointed at the next Atlanta Senate Meeting, and he hopes that this will help Perimeter and Atlanta students lobby for their campus. He is also working to solidify food options with Senator Tshizubu for commuter students. This option would allow students a certain number of swipes at Panther Dining.
  - B. **Alpharetta Campus**
    - i. **EVP Ritterbusch** – Looking to have a Clinic Cabinet in the Library. Had an event called Happy Hour which had the highest number of attendees on the Alpharetta campus at 190. Another event was the Escape Room in which they were able to register 18 people to vote, which is quite significant since there is a decent number of students on campus who are not old enough to vote.
  - C. **Clarkston Campus**
    - i. **EVP Henry** – Also, working on better food options on campus. They have successfully established meal options with vegan and vegetarian options, still working on having halal options available. Since Clarkston is the most diverse campus, they are working to have a week to celebrate where they can have different food each day of the week. She is working with the cafeteria and dining on that. She has a meeting planned with the person over the library at the Clarkston Campus in regards to the Relaxation Station for mental health. The Flower Initiative has gained support from Planned Parenthood and Generation Action.
  - D. **Decatur Campus**

- i. **EVP Manais** – Begin year with a “Back to The Book” event, where they partnered with PAC and passed out school supplies. We attached surveys to the event meaning that in order to get the supplies you had to fill out a survey. She shared these notes with **Alladin and Freeman** in hopes of using that information to develop a sampling day where students can try out the new options before they put it on the menu. The hurricane did push shipment back, so they are looking to reschedule a day for the event. She has also been in contact with Panther Dining in regards to a Grab N’ Go station for students on the Decatur Campus so that way students don’t have to wait in line and risk being late to class. She talked to Mr. Butler, who is head of sanitation on the Decatur Campus, about getting a deep cleaning done of the school due to the responses in the survey suggesting that students were dissatisfied with the cleanliness of the campus. They hosted their first Table Talk in which they had 13 students attend. EVP Manais also congratulates her Senator of Clubs and Organizations, Janii McIver, for a successful job in organizing SGA’s role in the Student Involvement Fair.

### **E. Dunwoody Campus**

- i. **EVP Alo** – Trying to host an event called Mascot Monday’s, where they can get Pounce onto the Dunwoody Campus and take pictures with him and post it in Instagram. They were also successful in their pop-up event where they were able to share what SGA is doing. Thirdly, they had a Student Involvement Fair and they participated in the Ninja Course. In the fourth week, they held another pop-up event for Constitution Day and they passed out pocket sized constitutions. They have a couple initiatives in the works that their Speaker is working on regarding food options and the parking lot.

### **F. Newton Campus**

- i. **EVP Turner:** Also had a Student Involvement Fair and thanks to her Senator for Clubs and Organizations, they had over 50 people stop by their table. They also had Constitution Day Tuesday and Wednesday of this week, and they helped people register to vote; about 5-0 in attendance as well. She tried to meet with the Access and Accommodation Center, however she has yet to receive a response back, but she will continue to try and contact them.

- a. **Advisor Beckwith** suggests that if she doesn’t hear anything, she should email the director directly, and she can find the information in the SGA Directory.

- G. **Communications Director Marlborough:** Commends the Alpharetta campus for raising \$300 for voter registration last week, as well as \$500 for National Voter Registration Day. Office Hours, the new web-series, will begin filming in October. It will be partnered with Panther Report News, filmed in the SGA Room. He will be reaching out to each campus’ Communication Directors, because each episode will have six students from each campus as well as alternates. Director Marlborough has solidified that the joint address with the State of Georgia will happen in January, around the third Thursday in January. Also discussed getting polling stations on the Dekalb and Alpharetta campus’ and working out a student poll worker schedule so students can be hired to run those polling stations.

## VIII. New Business

- A. **President Mejia** introduces the University-Wide Bill 90-UWB-0, Location Rotation presented by Senator Mclver.
- i. **President Mejia** wants to acknowledge that, originally, to introduce a bill it would go through a first reading, and then referred to a committee. However, the two bills that are being introduced were sent to the Bylaws Committee first which surpasses the first reading. She entertains a motion to override the first reading.
    - a. **Senator Milani motions to override the first meeting, seconded by Senator M. Jones.**
  - ii. **Senator Mclver reads her bill.** This bill would allow the President and EVP's to make a schedule that allows for a rotation of the locations between the Atlanta and the five Perimeter Campus, +for the University-Wide meetings in an effort to bridge the disconnect between Atlanta and Perimeter Campus. This legislation would not take effect until the next administration.
  - iii. **Senator Walton motions to discuss for 10 minutes, seconded by Senator J. Jones.**
  - iv. **Senator Abraham, point of information:** One question is that... well not a question. The perimeter campuses are um... y'all get money back for coming here on Atlanta Campus, and there are less Perimeter students coming on Atlanta Campus and so that does come out of Atlanta budget. So, if Atlanta students were to go to a Perimeter Campus that would have to come out of Perimeter, correct?
  - v. **President Mejia:** I'm sorry, could you speak up a little louder.
  - vi. **Senator Abraham:** That would have to come out of Perimeter's Budget if Atlanta Students...?
  - vii. **President Mejia:** I don't think so.
  - viii. **Advisor Beckwith:** No, the Perimeter Budget's pay for when the Perimeter students come together for campus visits, since it's so much fewer of them. It would not be financially feasible for Atlanta Senators to be reimbursed to go to one of the Perimeter Campuses.
  - ix. **EVP Habibur Rahman:** Our transportation budget is not big enough.
  - x. **Senator Abraham:** But Perimeter's is?
  - xi. **EVP Habibur Rahman:** Perimeter's is big enough to fund their travel to Atlanta, yes.
  - xii. **Senator Abraham:** That's all I wanted to know.
  - xiii. **Senator Mclver, point of inquiry:** Speaking for Decatur only, our advisor, she pays for our parking here because you have to pay for parking but parking is free at the Perimeter Campuses, and the Student Center has vans. EVP's can take a van training so you guys can drive together to the Perimeter Campuses.
  - xiv. **Advisor Beckwith:** We don't have enough vehicles for that many students.
  - xv. **EVP Habibur Rahman:** And I can only drive six people.
  - xvi. **Senator Mclver:** And there is also a WebEx option.
  - xvii. **EVP Habibur Rahman:** There is not for Atlanta, it is only available for Perimeter.
  - xviii. **Advisor Beckwith:** That's because we meet on the Atlanta campus.
  - xix. **EVP Habibur Rahman:** That's because we meet on the Atlanta campus, so the bylaws-
  - xx. **Senator Mclver:** But if you were-

- xxi. **EVP Habibur Rahman:** -would have to be changed before you could bring this bill to the floor. If that's what you want to do.
- xxii. **Senator McIver:** Sorry I'm trying to go off my notes. I'm going to read exactly what my notes say.
- xxiii. **Senator Johnson:** You good sis, take your time.
- xxiv. **Senator McIver:** Ok, so the questions that I thought you guys were going to pose were: 1) What about the Senators that don't drive? I was going to say carpool, and reimbursement for gas and also, 2) How is it good stewardship for our students dollars if we are only changing the location and we have to meet anyways? And then I already spoke about the vans and the training classes...yeah. I already spoke all my notes.
- xxv. **Senator DeHart:** My question concerned the WebEx options so I got it covered now.
- xxvi. **Senator Le:** I just want to say that, first, since Georgia State and Perimeter are all one institution now, parking permits are also shared among them so-
- xxvii. **President Mejia:** Address the chair.
- xxviii. **Senator Le:** Ad-Address the chair?
- xxix. **President Mejia:** Yeah. So, it's not- Address me, when answering the question.
- xxx. **Senator Le:** Oh! Wait, am I supposed to address you?
- xxxi. **President Mejia:** Well, Yes.
- xxxii. **Advisor Beckwith:** Everyone, is supposed to address the chair.
- xxxiii. **Senator Le:** Ok, sorry. So, I want to say the um, we're one institution so that means we also share parking permits. Previously, Perimeter Students had parking stickers instead of the hangtag. But they changed it so that all campuses use the same hangtag. Therefore, Perimeter now has free parking on Atlanta via the blue lot. They have the option to pay a discount at the parking deck but it is not required. Secondly, we already provide WebEx options for Perimeter Senators and their SGA as well and so keeping that in mind I think that it is not necessary for us to keep rotating locations. This coming from me as both an Atlanta Student and a previous Perimeter student. I just don't think it is very feasible.
- xxxiv. **Director Malbrough, point of information:** I will say just speaking on the WebEx option, I personally troll, even I called into a meeting on the Atlanta campus for a UEC meeting and, I personally, I had experience with WebEx both as a facilitator and as an audience member, and I can tell you WebEx is not an effective way for that. And just saying, and I think it is a disservice to our senators who had to travel here, to say we'll use WebEx when WebEx is in a way, an ineffective way to host a meeting with people who are um... who have to travel. And I think that is all I have to say.
- xxxv. **Senator Hassan, point of privilege:** I hear valuable discussion, but I just can't hear.
- xxxvi. **President Mejia:** Yeah, please project your voice (Addressing the Senate). Can you hear me? (Addressing Senator Hassan)
- xxxvii. **Senator Hassan:** I can hear you. I think it's because you have a microphone, but I'm not sure about the senators and the other people who are speaking. It's really hard to hear what's being said.
- xxxviii. **Advisor Sutton:** The room mics are at the front of the room.
- xxxix. **Advisor Beckwith:** The third and in the ceiling.

- xl. **President Mejia:** Yeah, so just try to speak as loud as possible.
- xli. **Advisor Sutton:** Or go down up front.
- xl.ii. **Director Malbrough:** But yeah, even with that, that kind of confirms my point. Just looking at policy, just saying that this is already working, its obviously not. So... I've completed [my statement].
- xl.iii. **Senator Mclver, point of information:** I'd like to know how many of you guys have actually been to the Perimeter Campuses, more than one of them?
  - a. **A few senators raise their hands.**
- xl.iii. **Senator Mclver:** Have you been to all of them?
  - a. **A couple senator raise their hands.**
- xl.iii. **Senator Mclver:** How can we be one GSU if we haven't frequented all of them?
- xl.iii. **Senator Walton, point of information:** The problem that the Atlanta campus will have is that, we're not going – who's going to go to a place when I don't get paid back for the gas money that I spent going somewhere. Unless, we can figure in our budget someway that we all get paid back. But, if there is no way that we can get paid back then it would be common sense if I'm going to lose money from something then I actually shouldn't vote with it.
- xl.iii. **EVP Manais, point of information:** How much gas are you really using getting from Atlanta to Decatur, and Atlanta to Clarkston. I mean I understand Alpharetta, Dunwoody, and Newton but you have to think they come to the Atlanta Campus too. So, to reiterate what Janii said, if we're going to be One GSU, and we want to be one SGA it starts here. So if we can't go to every campus – the UEC is doing rotation of every campus for a UEC, so I don't understand what's difficult about people carpooling or even getting in vans for people who don't want to drive, people who don't want to waste their gas, and coming to different campuses.
- xl.iii. **EVP Henry, point of information:** I do feel like it would be valuable for all SGA student to view every campus. I feel like that's something that is valuable.
- xl.iii. **Director Malbrough, point of information:** I'd also like to add that especially as Atlanta students, cause I've been in SGA for one year but as a student on the Atlanta Campus, I've been able to go to all the SGA meetings because I live on campus and I go to class on campuses so if you also want to open it up, we also have to take into consideration Perimeter Constituents will want to view a University-Wide Senate Meeting, who won't have the opportunity to because you could say that the senators travel gets reimbursed but the constituents don't.
  - i. **Senator Mclver, point of information:** We actually don't get reimbursed for our gas.
  - ii. **Advisor Beckwith:** You should be.
  - iii. **Senator Mclver:** But we don't.
  - iiii. **Advisor Beckwith:** If you need to, speak to your advisor.
  - lv. **Senator Mclver:** But she pays for our parking here.
  - lv. **Advisor Beckwith:** Parking and mileage should both be reimbursed.
  - lvi. **EVP Henry:** I believe it was if it's not a WebEx option, then you get reimbursed for gas and things like that but it's just the parking.

- lvii. **Advisor Beckwith:** No. Yeah, at any point in the past the Perimeter Budget have – should be taking care of a parking and mileage to come to the Atlanta Campus. Marshontri, can you weigh in on that?
- lviii. **Advisor Reid:** I’ve never outlined my budget to cover both parking and mileage. I’ve always outlined my budget for parking only.
- lix. **Advisor Williams:** I’m sorry I couldn’t here that.
- lx. **Advisor Reid:** April this Marshontri.
- lxi. **Advisor Beckwith:** You’re in the back of the room without any microphones. So, April the issue is clarifying if the advisors have been reimbursing both travel, mileage and parking or just parking?
- lxii. **Advisor Williams:** I think that was more so to the discretion of the campus based on the Student Activity Fee during the deliberations, depending on how that was allocated. I am 100% confident, that is certainly a discussion that comes up, considering the fact that those fees have just have gotten a lot shorter and shorter. I can tell you that—to be very clear it has been an open option that both parking and mileage should be reimbursed if the allocated funds were there. So that really goes back to those deliberation processes, as it would even the College-Wide Leadership Budget when it comes to travel for the University-Wide President as well as our university-wide retreats and how that money is allocated. So, it’s to the discretion of the SAF Deliberation Budget Committee which is a makeup of many of those individuals in the room, especially coming up.
- lxiii. **Senator DeHart, point of information:** I would like to get to an opinion on this. So, I know we said that if we were to switch over, we would have to change our bylaws to allow an Atlanta Campus Senator to be paid back for travel, for that to be possible? We would have to change our bylaws?
- lxiv. **Advisor Boyd:** You would have to not only change the bylaws; you would also have to get the Atlanta Student Activity Fee Committee to allocate the money that would cover the expense.
- lxv. **Senator DeHart:** Right, which is what I was going to direct towards EVP Rahman. Do we have a transportation budget on our campus?
- lxvi. **EVP Habibur Rahman:** We do but it is very miniscule because the only expected transportation cost is coming to me or the speaker for NCLC and NACA, respectively...
- lxvii. **Advisor Beckwith:** ...and Board of Regents and SAC Meetings for the—
- lxviii. **EVP Habibur Rahman:** And SAC meetings. So, it isn’t a big budget that can sustain 30, what is it 31 senators as of now? And not only that but, it is sort of a bad way to spend our students’ money if we’re moving 31 people for every single meeting, actually we would be moving more because we would have to compensate Perimeter Senators to go to whatever Perimeter Senators. So, we at least—the maximum number of senators on the Perimeter Campus I believe is five.
- lxix. **Advisor Boyd:** Six.
- lxx. **EVP Habibur Rahman:** Six? Meaning we would have to move 40 people, every time and pay for 40 people to leave every single time. In my opinion, this is just not an effective way to spend our money.

lxxi. **Advisor Sutton, point of information:** The bylaws don't address the process, in terms of what is funded or not funded. The bylaws address that there is currently only a WebEx option for Perimeter students. It does not allow for the Atlanta Campus to request the WebEx option the way they are presently written. If you have your SGA Binder with you, from the SGA Retreat, the Atlanta budget is in the Atlanta binders, and the Perimeter Budget is in the Perimeter binders, so if you want to see what the Atlanta budget looks like for the Atlanta Representatives it is in your binder in the financial section.

### **B. President Mejia gives Senate 1-Minute Warning**

- i. **Senator Walton motions to add 5-Minutes to discussion, seconded by Senator Abraham.**
- ii. **EVP Manais:** One thing that I also want to highlight is that it's not just Atlanta because I feel like we're focusing on how this affects Atlanta, or Atlanta's budget. Decatur's not close Newton, Decatur's not close to Alpharetta. We're all taking, a sacrifice basically, to travel to these different campuses to see issues. I don't know what Newton looks like and I don't know what their Disability or Accessibility Center -- I don't know their issues. I would get to know once I go over there. It's not just Atlanta, we're not saying "oh we don't like it at Atlanta," we just want to make sure that every campus in SGA is represented.
- iii. **Senator Walton, point of information:** On Line 14 it says, "whereas we are one SGA, and are the voices for all campuses. That statement is true. We are one SGA and the voices for all campuses but also our SGA, how we're structured is, if your Atlanta Campus you come with Atlanta issues to the U-Wide Senate and vice versa. And I just don't think going to a campus is going to help Perimeter issues.
- iv. **Senator Aiken, point of information:** As she mentioned before, that the Decatur Campus is further away from other campuses and vice versa. I just feel like if Atlanta is the central location –
- v. **EVP Manais:** It's not.
- vi. **EVP Henry, point of information:** Clarkston is the central location.
- vii. **Senator Aiken:** Well, whichever campus happens to be the central location. I don't know if switching campuses is the answer rather than finding a central location for us to have the meetings at so everyone can be spending the same amount of gas and the same amount of travel time.
- viii. **Senator Abraham:** To reiterate what you were saying, you would have to also take the cost of a Perimeter Campus coming from their Perimeter Campus to another significantly further Perimeter Campus. You said that you didn't know what Newton looked like but you have to also budget for Newton—
- ix. **Senator M. Jones, point of information:** Is it possible for there to either have a mic be moved to the back or for a person with a mic to repeat shorthand what is being said.
- x. **Advisor Boyd:** Or speakers come to the front in order to be heard.
- xi. **Senator M. Jones:** It doesn't have to be all the way but just enough so that if you are in the back you're not having to shout.
- xii. **Senator Abraham:** Okay, can you hear me now?

- xiii. **Senator M. Jones:** Because we can't hear you at all.
- xiv. **Senator Abraham:** Can you hear me now?
- xv. **Senator M. Jones: Yes**
- xvi. **Senator Abraham:** Okay, thank you. So, like I was saying, it's that you would have to also budget for an Alpharetta student coming to Newton's campus or a significantly further Perimeter Campus student going to a significantly further Perimeter Campus. So, it's not that it's just an Atlanta issue, it's also Perimeter you would have to manage your time for the extra mileage you would have to go to a significantly further Perimeter Campus.
- xvii. **Senator Milani:** I just wanted to say, I feel like, we are like a united GSU. But to like show more union like I feel like it is respectful for like people in Atlanta to go to Perimeter Campuses, because if they're making strides to come here like, yes I know they have a WebEx version but they are here at the end of the day, like some of them are here. So, I feel like, we can also do the same by going to their campus'. And I feel like, maybe like once a semester minimum or you know, I feel like that would be feasible. If not, like to your point Hamza, like I feel like, it wouldn't be so much as funding every single senator that we have as we can also have options for carpool or we can do that sort of thing where we go there together and come back together. So, we wouldn't be paying for each individual person. It would be more of like, a group.

### **C. President Mejia gives Senate 1-Minute Warning**

- i. **Senator DeHart, point of information:** I just have a general question. I haven't attended any of the Perimeter Campuses for any classes but what is the latest class time at the Perimeter Campuses? That's a general question; anyone can answer.
- ii. **EVP Henry:** To my understanding, it's about 9.
- iii. **Senator DeHart:** PM?
- iv. **EVP Henry:** Yes.
- v. **Senator DeHart:** Ok
- vi. **Senator M. Jones, point of information:** I do believe that is start time for the class.
- vii. **Senator Walton motions to extend discussion time by three minutes. No second.**
- viii. **EVP Henry, point of information:** This would only be once a month everyone. So, it's not like we're going to do this regularly. It's only one time in a month that you have to drive somewhere else. I've driven to Alpharetta. I've been to almost every campus and I don't ask to get reimbursed for it cause it's just one time.
- ix. **Senator Ebiringa motions to extend discussion time for 10 minutes, seconded by Senator Tshizubu.**
- x. **Senator Cornett, point of information:** I just want to say that, not everybody that goes to the Atlanta campus, lives on the Atlanta campus. So, like I commute, like about 30 minutes maybe an hour to get here and for me to go all the way to Alpharetta would be or like Newton or anywhere like that would be out of my way.
- xi. **Speaker Reid, point of information:** PC doesn't live on Atlanta Campus either, and we have to travel too. Including the WebEx that is not working right now, is proving this point.

- xii. **EVP Henry declares point of privilege as she is unable to hear Speaker Reid from the front of the room.** Speaker Reid repeats herself while adding, that saying WebEx is an option when it doesn't work isn't really an option.
  - xiii. **Senator Cornett, point of information:** Perimeter students are allowed to live on the Atlanta Campus if they choose to do so.
  - xiv. **Senator McIver:** After getting off the waiting list?
  - xv. **Senator Rainer calls to question, seconded by Senator McIver.**
  - D. **President Mejia opens vote for the bill, but due to overlapping conversation Senator Walker and others were confused on who called to question, which is clarified as Senator Rainer and seconded by Senator McIver.**
    - i. **Speaker McDonald, point of inquiry:** Doesn't it say in the bill that it is effective immediately. Why is it for next administration?
    - ii. **President Mejia:** Because in the bill it states that it will be determined every June 1<sup>st</sup>, and we already passed June 1<sup>st</sup>. Does that make sense?
    - iii. **Senator DeHart, point of information:** Will this take effect at the one coming up or...?
    - iv. **President Mejia:** The next administration. The 91<sup>st</sup> Administration.
  - E. **President Mejia opens voting for the bill again, but Senator Walker informs President Mejia that since there was a call to question, there needs to a vote to end discussion and bring the vote to the floor.**
    - i. **Motion passes to end discussion and call to question: 28 Votes For. 0 Against. 0 Abstained.**
  - F. **President Mejia opens voting for Rotation Location Bill.**
    - i. **Motion Fails. 9 Votes For. 15 Against. 4 Abstained.**
  - G. **Senator McIver presents her next bill, pertaining to the Perimeter Campuses Only. 90-CB-PER-01.** This bill will amend the meeting protocol for Perimeter Senate Meeting in efforts increase student participation. The Speakers of Perimeter Campus will provide designated times and places for bi-weekly meetings at least 9 weeks before the beginning of the semester.
    - i. **Senator Abraham, point of inquiry:** Is this only for Perimeter?
    - ii. **President Mejia:** Yes.
    - iii. **Senator M. Jones calls to question, seconded by Senator Mackey.**
      - a. **Motion passes. 4 Votes for. 0 Against. 2 Abstentions.**
  - H. **Senate Committee Sign-up**
    - i. **President Mejia** presents Excel spreadsheet with University-Wide Committee meetings for Senators to choose. Due to conflicts with meeting times and Senators schedules EVP Rahman asks Senate if they would be willing to meet with him and President Mejia after the meeting to sign-up and discuss any conflicts.
    - ii. **Senator Mackey motions to dismiss the Committee Sign-Up, seconded by Senator Minetos.**
